



## TERMS AND CONDITIONS "RACE TO WIN" ON-LINE GAME

1. Tabcorp Manager Pty Limited (ABN 98 064 304 016) ("**Promoter**") is the promoter of the "Race to Win online game" promotion ("**Promotion**").
2. The promotional period for the Promotion commences at 12.00am on Monday 20 February 2006 and ends at 11.59pm on Sunday 26 March 2006 ("**Promotional Period**").

### ENTRY REQUIREMENTS

3. In order to be eligible to participate in the Promotion, persons must be Australian residents and over 18 years of age.
4. Eligible persons ("**Players**") can visit [www.tabaret.com.au](http://www.tabaret.com.au) ("**Website**") during the Promotional Period and correctly register their details in (at least) all the mandatory fields of the online registration form to be eligible to participate in the Promotion. Once all the mandatory fields have been completed by a Player, the Player can play the 'Race to Win' game that is available on the Website during the Promotional Period for the chance to win a daily prize ("**Daily Prize**") and/or the major prize ("**Major Prize**") in the Promotion.
5. Players acknowledge that their details as inserted in the online registration form will be entered into a database and any member of the Tabcorp group of companies (and their agents and contractors) may use the Player's name, postal address, email address and telephone number for future marketing, promotional and market research purposes unless the opt out box is marked on the online registration form. Players acknowledge and agree that by not marking the opt out box on the online registration form, their details may be used in this manner (including for gaming machine advertising) and that they will be deemed to have requested such information.
6. To be eligible to win a Daily Prize, Players must complete all 3 levels of the 'Race to Win' game on the Website ("**Game**") during the Promotional Period. The time taken to complete each game will be recorded for each Player.
7. Daily Prizes will be awarded to the Players who have recorded the 10 fastest times from playing the Game during each period from 12.00am to 11.59pm on each day during the Promotional Period (each a "**Day**").
8. Daily Prizes will be as follows:
  - (a) For the Player who has recorded the fastest time playing the Game on a Day – one \$10 Tabaret Venue voucher which will be redeemable for goods and services excluding TAB and bottleshop at the participating Tabaret venue named on the voucher at any time before 11.59pm on Sunday 26 March 2006 and one Scratch Ticket for Tabaret's 'Race to Win' promotion which runs from 12.00am on 20 February 2006 to 11.59pm on 26 March 2006 (see the promotion section of [www.tabaret.com.au](http://www.tabaret.com.au) or in-venue for full terms and conditions) ("**Race to Win Promotion**").
  - (b) For each of the Players who have recorded the second, third, fourth and fifth fastest times playing the Game on a Day – one \$5 Tabaret Venue voucher which will be redeemable for goods and services excluding bottleshop at any participating Tabaret venue at any time before 11.59pm on Sunday 26 March 2006 and one Scratch Ticket for the Race to Win Promotion.
  - (c) For each of the Players who have recorded the sixth, seventh, eighth, ninth and tenth fastest times playing the Game on a Day – one Scratch Ticket for the Race to Win Promotion.

Tabaret Venue vouchers must be used in a single transaction at the participating Tabaret Venue named on the voucher and no change will be given if the full amount of the voucher is not spent in a transaction. Only one voucher may be used for each transaction.

9. The Major Prize will be awarded to the Player who has recorded the fastest time playing the Game during the Promotional Period and will be a cheque for \$200.
10. Each Player that wins a Daily Prize will be notified via e-mail within 7 days of the Day in which they recorded the time that qualified the Player for a Daily Prize. Details of how to claim the Daily Prize will be included in this email.
11. The Player that wins the Major Prize will be notified via email by Tuesday 4 April 2006 and the email will include details of how to claim the Major Prize.
12. Daily Prizes and the Major Prize are not transferable or redeemable for cash.
13. Players who claim Daily Prizes and/or the Major Prize may be required to present one form of valid photographic identification (passport or Australian drivers licence) or two forms of valid non-photographic identification acceptable to the Promoter in order to claim the Daily Prize or the Major Prize (as is applicable).

### GENERAL

14. The Promoter reserves the right to cancel or change the prizes offered under the Promotion due to circumstances beyond the Promoter's control or if there are any changes to the law which would or might render the Promotion or any prizes offered under the Promotion unlawful. The Promoter reserves the right to substitute any Prize (or part of it) for an item of similar value.
15. The total possible prize pool is \$1,250.00.

16. Decisions of the management of the Promoter are final. No correspondence will be entered into.
17. To the extent that a situation or issue arises for which these terms and conditions make no provision or in relation to which the relevant terms and conditions are unclear, the Promoter also reserves the right to make a decision regarding such situation or issue in its sole and absolute discretion and such decision will be final and binding.
18. To the extent permitted by law, the Promoter shall not be held liable for any loss, damage or injury suffered or sustained (including, without limitation, direct, indirect or consequential loss) arising directly or indirectly out of or in connection with any participation in the Prizes by any person or in connection with the Promotion.
19. Directors, management and employees of the Promoter or of any of the TABCORP group of companies (including TAB, Star City and Jupiters companies) and their immediate families are not eligible to participate in the Promotion.
20. Directors, management and employees of any Tabaret Venue and any agencies associated with the Promotion and each of their respective immediate families are not eligible to participate in the Promotion.
21. Participation in the Promotion by a Player confirms acceptance of the terms and conditions governing the Promotion.
22. All details inserted on the online registration form become the property of the Promoter.
23. The laws of the state of Victoria govern the Promotion.
